# What Makes Rotary Unique?

Speech made by PDG Dr Philbert Chin at the Rotary Club of Singapore's weekly meeting on 17 January 2018:

In 2003, at a Presidential celebration, Cliff Dockterman, RI President, 1992-1993, delivered a speech, titled "**Vocational Service – Rotary's 1**<sup>st</sup> **concept**".

This speech inspired me to write today's paper and I will share some of his thoughts with you.

Rotary was the 1<sup>st</sup> business-orientated organisation of its kind in the United States; and, at the same time, it is the oldest service organisation in the United States.

Is this a contradiction in terms?

Rotary was founded on a cold wintry night, 23 February 1905 in Chicago, USA, a city described by Upton Sinclair in his book, "The Jungle", as a "great sore city, it was dirty, it was corrupt and it was the home of Paul Harris".

Paul Harris, a 27-year-old lawyer, who found it difficult to settle down in Chicago with 3 other friends set out on that dreary night to form a club. This club would include members, each from different business, who would gather for friendship, mutual cooperation and help each other to promote business. They could join only if another member youched for them.

Thus, was established Rotary's classification system. At the same time, diversity became part of Rotary's culture.

At the time of formation of the club, Paul Harris, the Founder, had this unusual idea that friendship and business might mix and result in even more business. Thus, the idea of **friendship and business were combined – and the 1**<sup>st</sup> **Rotary Club evolves**.

The founders named the club, "Rotary", because initially members met in each other's office by rotation.

When the Rotary Club of Chicago was formed, written in its constitution were 2 Objectives:

- The concept of Friendship.
- The promotion of the business of its members.

In 1907/1908, Paul Harris became the 3<sup>rd</sup> President of his club. Once again, he introduced another innovative idea. This time, he felt that since friendship and business could mix, so could **business and service be combined.** 

This was apparent in the initiation of Rotary's 1<sup>st</sup> 2 community projects, namely;

- Donating a horse to a Doctor for him to continue doing house calls.
- Building public toilets in downtown Chicago.

These projects showed that Rotarians could adopt the challenges of their community needs and set an example that was the fore runner of the countless similar services rendered by Rotarians throughout the world.

In 1912, at the Convention held in Minnesota, the original objectives encompassing the promotion of business was discontinued. Personal, selfish gain as a moving force was officially eliminated. However, through the many changes made in the "Object of Rotary", **the business element was retained.** It is in fact listed as part 2 of the present "Object of Rotary".

- To encourage high ethical standards in business and profession.
- To Promote the worthiness of all useful occupations and the dignifying of each Rotarians occupation as an opportunity to serve society.

Friendship, business and service has become intertwined in the culture of Rotary.

It is interesting to note also that as early as 1917, Lesley Pidgeon, RI President, stated "the primary object of Rotary is to relate the individual properly to his daily work, that is the 1<sup>st</sup> duty Rotary has do perform. The Rotary club must educate its members to embody the ideal of service in their daily work"

In the book printed in 1935, on the early history of Rotary in Great Britain, T.A. Warren, who became President in 1945-46, stated, "the only unique feature of Rotary is Vocational Service; everything else we do is repeated by some other organisations. If we are unique, if we have a special message or mission in the world that is unique to ourselves, it lies in the realm of Vocational Service".

"Vocation service" was clearly the main focus of Rotary. What then was the outcome?

# 1<sup>st</sup> Outcome:

- Rotarians helping each other. It was this concept of promoting business that led to Rotary's 1<sup>st</sup> community project - installing the 1<sup>st</sup> public restroom in downtown Chicago. When service is provided, business is enhanced. It was on that basis, that the world 1<sup>st</sup> community service was launched.

# 2<sup>nd</sup> Outcome:

 Rotarians took to promote ethics and integrity in their vocational practices. In the early meetings of Rotary, members frequently discussed techniques to improve business practice and offered wise and friendly counsel to each other.

Soon, members felt that they could do business with their Rotarian friends. They could expect to be treated fairly and there would always be an ethical element in all their transactions. Thus, the word, "Rotarian" was considered a mark of distinction in the business world.

Rotary Clubs were then regarded as leaders in fighting corruption and unfair business practices.

In 1910, Arthur Sheldon spoke at Rotary's 1<sup>st</sup> convention in Chicago, saying "as man come to the light of wisdom, he comes to see that right conduct towards others pay, that business is the science of human service and that "he profits most who serves his fellow best", thus, Rotary's 1<sup>st</sup> motto came into being – "a basic principle of business ethics".

In 1911, Ben Collin, who was asked to speak at the convention in Portland, mentioned that his club used the principle, "**Service-Above-Self**" in all their vocational activities. This impressed delegates and was adopted as Rotary's 2<sup>nd</sup> motto. With slight changes, both were officially adopted as Rotary's motto at the 1950 convention.

Rotary's continued "obsession" with the promotion of ethical practices and integrity continued with the adoption of several guiding principles, including the "4-Way-Test".

It is interesting to note that at the Convention held in Belgium, 1927, Rotary officially adopted the word, "Vocation" to cover all useful occupations. So, when the "Object of Rotary" was re-written, "Vocational Service" became the 2<sup>nd</sup> part of the "Object of Rotary" and Rotary's 2<sup>nd</sup> "Avenue of Service".

Unfortunately, I can't find anywhere why this was done. To me the word, "vocation "meant more than work, it is a calling. I believed that Rotary must have wanted all Rotarians to regard their business and profession, a calling, so as to achieve the ideal of service and doing "Service-Above-Self".

In 1960, in order to promote "Vocational Service", Rotary International introduced the case studies of principles and new methods of handling business situation. A booklet called, "Let's get down to cases" was also published. They provide Rotarians with the chance to explore moral business and ethical dilemmas.

In 1989, the Council of Legislation adopted a statement, called "a declaration of Rotarians in business and profession". This again reiterated that a Rotarians vocation is considered "to be an opportunity to serve society" and an obligation to attend to the problems of the community.

It is a pity that Rotary did not take steps to promote **Corporate Social responsibility (CSR)** as part of a Rotary's obligation to serve society through vocational service. However, it is too late to champion this cause.

In 1934, at the St. Louis convention, RI President, Will Manier, drafted a fundamental statement which was adopted. This stated, "fundamentally, Rotary is a philosophy of life that undertake to reconcile the ever-present conflict between the desire to profit for one's self and the duty and consequent impulse to serve others. The philosophy is the philosophy of service – "Service-Above-Self" – and is based on the practical ethical principle that "He Profits Most Who Serves Best". That is the basis of all vocational service in Rotary.

Recently, I came across video in YouTube, downloaded by a Rotarian, Haresh Ramchandani, from the Rotary Club of Montevideo, he visualises Rotary as a tree, he called the "root" - club service, the "trunk" – vocational service, the "branches and the leaves" - community service, international service and the "fruits" - the Rotary Foundation.

He continued, "without club service, the "root", without fellowship, friendship and the overall atmosphere and events that took place in the club, you can't have the tree. Likewise, without vocational service, the "trunk", that element of people that bring expertise to the table, you can't have all the services".

So, the "tree" simplifies how important vocational service is to the world.

Perhaps, all Rotarians should regard Rotary as a "tree", with club service and vocational service being responsible for the type of services Rotary renders.

When Rotary started, there was disruption in society and Paul Harris introduced the 3 elements that make Rotary grow – Friendship, Business, Service. Today, there is even greater disruption – unethical and illegal practices flourish, confidence in business and professional trust have been eroded and lost.

If vocational service was the basis of Rotary's activities in the beginning of the  $1^{st}$  century, I believe this is time to restore business and professional ethical concerns as Rotary's primary responsibility as we approach the  $2^{nd}$  century.

The challenge is for all Rotary clubs to take on the task.

Let me end by quoting a passage from our Founder, Paul Harris:

"Whatever Rotary may mean to us, to the world, it will be known by the results it achieved"

# **Speaker:** Past District Governor Dr Philbert Chin

Topic: "What makes Rotary unique?"



When President Keith invited Honorary Member (HM) PP Raymon Huang to introduce the Speaker, none other than PDG Dr Philbert Chin, HM PP Raymon remarked that it was unnecessary and redundant to do so, since PDG Philbert was known to everyone in the Club, in the District, in many of the Rotary Clubs in the region as well as in Rotary International circles.

HM PP Raymon Huang District Governor in 1983/84 – his meteoric rise reflected his drive and dynamism. He introduced "PETS" (President-Elect Training Seminar) to the District, chaired the Asia Zone Institute and the Host Committee when the first Rotary International Convention was held in Singapore in 1999. PDG Philbert also authored two excellent Rotary pieces – "60 Years of Service" and "The Guide To Daily Living". For his services to Rotary, PDG Philbert was recognised and bestowed by Rotary International with many accolades and honours as his work in Rotary is legendary.

Outside of Rotary, HM PP Raymon advised that PDG Philbert has contributed to society and the country in serving on many Boards. For all of this, the Singapore Government has conferred upon him several National Day Awards. One premier Voluntary Organisation, PDG Philbert founded with the strong support of the then Prime Minister, Mr Goh Chok Tong, was "RSVP" – the Organisation of Senior Volunteers. HM PP Raymon then invited PDG Philbert to address the Club.
